- The Elementary School has finished interviews for the interventionist position and we will be
 offering that position to Denise Short. We are still discussing the options for the ½ time
 computer teacher position.
- The administrators attended a principal evaluation workshop at NCRESA.
- The Alumni dinner and monitor presentation went very well.
- There will be a staff breakfast on August 25th from 7:30 a.m. to 8:00 a.m. with professional development for the teaching staff during the day. The open house is scheduled from 5:00 p.m. to 7:00 p.m. on August 25th along with the first home football game.
