- Spring conferences had a strong turnout with 75% of students being represented.

- Third quarter Fountas and Pinell Benchmark assessments were presented. Comments were made about the third grade class’s progress. Next fall the students will be in three sections, which will result in smaller class sizes and allow for better behavior control.

- We will be working on the calendar in negotiations.
- The video promoting Hesperia Community Schools will be posted to social media.
- The State is looking at paying for NWEA testing for next year.
- We have six students who have applied for the Early College program.
- The Lockout Company (Boots and LED lights) is looking at connecting with a TV show called The Profit to profile the company's product. If they are selected, the show may film them finishing the installation of the lights and allow us to highlight what we are doing for school safety. This will be another favorable promotion for our district.
- Several schools are budgeting less students for next year's budget.
