Hesperia Community Schools Board of Education August 6, 2018 Workshop/Special Meeting

The work session/special meeting was called to order by Board President Scott Wenberg at 7:00p.m. in the High School Media Center.

Agenda Change

Facilities/Grounds/Technology

- Asphalt crack sealing was discussed. A board discussion/action matrix and an estimate from Ravenna Sealcoating of Fremont were handed out and discussed. It is estimated between \$1,500 and \$2,000 to repair the worst areas. We will spend up to \$2,000 out of this year's maintenance repair budget to make any necessary repairs, going higher only if a repair can't wait longer.
- High school/middle school cafeteria air conditioning was discussed. A quote of \$6,967.85 from 1st Choice Heating & Cooling was handed out and discussed. This quote was to replace the compressor with a remanufactured compressor. It was decided to wait till spring to make any decisions and maybe contact Scott Rumsey about compressors.
- Playground equipment update was discussed. The equipment that was to come to us didn't
 pass inspection so we are not getting any equipment at this time but maybe in the future if a
 grant can be secured.
- Playground fencing was discussed. We are waiting for gate prices from Affordable Fence and a possible donation from them. We will move ahead with this project in order to get it completed before the beginning of the school year.

- It was suggested that Scott Rumsey, athletic boosters and the new A.D. look at getting a beverage contract with either Coke or Pepsi. Contracts are similar.
- On Wednesday, August 8th, three applicants will interview for the history teacher/athletic director position. Broton and Daniels will replace Good on the interview committee.
- It's too soon to know student numbers.
- Student handbooks address bullying as does the Be Nice Program
- A thank you to the HEA for negotiating and settling the master contract.
- Remember to vote tomorrow as the local library has an item on the ballot.
