## Public Comment

Rebecca Kamphorst, Special Education Teacher- Read a letter to the board concerning the potential absorbing of positions in the district.

She voiced concerns about class size and how it will effect student education.

She strongly encouraged the administration to avoid a grade level split.

Theresa Dean-Rumsey, High School English Teacher- Her focus was on the current curriculum's AP course offerings. She suggests we keep the availability of these courses for our students. The rigor of these courses prepares students who are college bound.

Jennifer Sherburn, High School Science Teacher and currently a parent of two students- It is important to keep a varied curriculum so that students have an opportunity to take a courses that they are interested in. We are here to provide the opportunity for the students to discover who they want to be, and if they want to challenge themselves we need to offer the courses for them to do so. While we often talk about our At-Risk population, that same body of students is overcoming the statistics. 18 out of the 55 students in the sophomore class have a GPA of 3.25 or high. That is 33% of the students in the class.

Daniels, board president, stated we (the board) know less about the proposed changes than you do. This is the first we are hearing about the situation from you, we the bard have a responsibility to help continue to do the good we have all worked so hard to build over the years. We must communicate with one another in order to ensure everyone is being heard.

There were additional comments made by staff to the board and an open discussion for about 10 more minutes. The decision to have a meeting on Thursday, 15 was made.

The discussion concluded with a statement from Mr. Mey superintendent.

"The meeting needs to be manageable and a collaborative effort. But, in the end there will still be cuts. Cuts feel more difficult now because we have become unaccustomed to them.

### Facilities/Grounds/Technology

Mr. Bryan Mey presented information about an overhaul to the current camera system.

Ken is doing a great job in Transportation as is Melody Leone.

We are looking at bussing options for next year. Our current lease is up in July.

## Finance

Mr. Mey presented information about the upcoming budget amendment and plans for an adhoc meeting on Wednesday, June 22nd, in the central office conference room.
