Mr. White, superintendent presented the following information:

- Presented Clarification regarding how "on-call classification" may affect HESPA staff
  members and their retirement reporting. Also let them know that we were working on some
  professional development at a building level for those that do not want their retirement
  affected. Also, took a moment to thank the HESPA staff for their understanding as we
  continue to navigate the changes.
- Thanked his administrative team for working so hard to understand, and implement the constant changes taking place in the reporting and processing of Covid-19 legislature.
- "We are in a Pandemic folks". Despite this we are seeing amazing things happening; staff and parents and administration are working hard together to education our students. Thanks to everyone for their hard work.
- Governor held a press conference which extended the High School's remote learning through December 20, 2020.
- No athletics can be held until December 21, 2020.
- High School Career Tech Center can reopen with restrictions on December 9, 2020.
- The extended learning year Covid-19 team met to discuss the return to school. They were all in agreement that in person learning is the best learning setting. The return to school could be generally based on four data points; (1) positivity rate for Covid-19 cases in Newaygo and Oceana counties, (2) the cases per million count trending in a downward pattern, (3) room/availability in hospitals for Covid-19 patients (4) work completion rates for students. The administration and board will make the decision when and how to return after the first of the year.
