Mr. Al Daniels responded to her concerns and apologized that she felt hurt. She continued with her concerns, addressing specific areas of the district. She address Mr. Mey who declined to address public comment. Mr. Daniels concluded by stating, “It is the schools job to determine if a concern needs to be followed up. It is your right to bring your concern to the administration and to the board. We are continuing to get education and guidance on how to handle “okay 2 say” situations. He concluded with, thanking her for voicing her concern.

Broton addressed the board concerned with student supervision during passing times. He stated his concern with student safety after recent events occurred during the student passing time in the week prior to the meeting.

Maynard stated that we need another administrator to help with student behavior, and asked if teachers were still required to stand in the hallways during passing time. Do we have unsupervised areas, or blind spots that need to be addressed?

Mr. Paine addressed her questions, stating “Teachers are always moving but students are always looking for the opportunity.” He agrees with Maynard that the district does not have as much supervision as neighboring districts.

Kraus asked if the discipline for the incident was sufficient. Paine replied that it was administered according to the handbook, but the board can review policies before the next school year and revise discipline if necessary.

The board discussed preliminary plans for the new class rank criteria.
